## Participant Release and Waiver of Liability

Please read carefully. This is a legally binding document that affects your legal rights.

This Release and Waiver of Liability (the "Release") executed on the date shown above by the person named above (the "Volunteer") shall be considered valid from this day forward in favor of The Church At BattleCreek, a nonprofit corporation, their directors, officers, employees, and agents (collectively referred to as "TCABC").

The volunteer desires to work as a volunteer for TCABC and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that Activities may include light construction, building projects, organization, loading and unloading materials, painting, finishing, transporting to and from project site and other related activities with the knowledge of the danger involved in these activities.

**Release and Waiver.** The Volunteer does hereby release and forever discharge and hold harmless TCABC and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise from the Volunteer's Activities with TCABC. The Volunteer understands that this Release discharges TCABC from any liability or claim that the Volunteer may have against TCABC with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Volunteer's Activities with TCABC, whether caused by the negligence of TCABC or its officers, directors, employees, or agents or otherwise. The Volunteer also understands that TCABC does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, dental, health, or disability insurance in the event of injury or illness.

**Theft or Loss.** I understand that TCABC is neither responsible nor liable for my personal effects and property. I will hold them harmless in the event of theft or loss resulting from any source or cause.

**Medical Treatment.** The Volunteer does hereby release and forever discharge TCABC from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with TCABC, or with the decision by any agent of TCABC to exercise the power to consent to medical or dental treatment as such power may be granted and authorized for treatment of a minor child.

**Assumption of Risk.** The Volunteer understands that Activities include work that may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from work sites. The Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and release TCABC from all liability for injury, death or property damage resulting from the Activities.

**Insurance.** The volunteer understands that, except as otherwise agreed TCABC in writing, TCABC does not carry or maintain health, medical, or disability insurance coverage for any volunteer. Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

**Photographic Release.** The volunteer does hereby grant and convey unto TCABC all right, title and interest in any and all photographic images and video or audio recordings made by TCABC during Volunteer Activities with TCABC, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other.** The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by laws of the State of Oklahoma and that this Release shall be governed by and interpreted in accordance with the laws of the State of Oklahoma. The Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining of this Release that shall continue to be enforceable.
